7. **Discussion Continued from December 20: Reviewing Design Guidelines for Possible Update.**

Currently the Design Guidelines discuss color choice briefly and is expressed only as a relationship between neutral walls and accented trim. PUBLIC HEARING PROTOCOL

The public is encouraged to participate in the public hearing process.

1. An agenda item is first introduced by the Planning Commission Chairperson.
2. The project is described in detail by a Planning Department staff member. As part of the project presentation, questions and answers between Commission members and Staff are included for additional information or clarification.
3. The Chairperson opens the public hearing.

In all cases, in order to obtain and maintain an accurate record of the proceedings, please use the speaking podium and clearly introduce yourself with your name and address and whom you are representing if you are representing a person or entity other than yourself.

- a The proponent/applicant presents the project first.
 - b The public will sign in on sheet provided. The Chairperson will invite those who have signed up to testify in order. It is requested that all presentations be limited to a maximum of five minutes so that all interested parties will have an opportunity to address the Commission.
 - c If anyone has failed to sign up and wishes to testify, he can do so after those who signed up have testified and before the public hearing is closed.
 - d Rebuttal from proponent.
4. At the conclusion of the testimonies received, the Commission Chairperson will close the hearing and limit discussion to Commission members.
 5. Planning Commission Discussion of the project. The public will not be permitted to speak while this matter is under discussion by Commission members. During this discussion, Commission members may individually ask questions of the project proponent or opponent, at the convenience of the Commission.

CONSENT AGENDA ITEMS

If it is determined by the Commission that a Consent Agenda item requires further discussion and review, it will be removed to the regular agenda for consideration. The remaining items will be handled as a group by a single action of the Commission.

RIGHTS OF APPEAL STATEMENT

In case of any protest to a Planning Commission action, protestant may within five (5) days, appeal such action to the City Council pursuant to the City Code.
